Final Notice to Slum dwellers staying in Dharavi Notified Area for not submitting required documents for Dharavi Redevelopment Project

*(Issued in Public Interest and in Compliance with the Principles of Natural
Justice)*

With the objective of ensuring comprehensive, equitable, and transparent redevelopment of Dharavi, this notice is being issued in public interest.

Whereas, the Dharavi Redevelopment Project / Slum Rehabilitation Authority (hereinafter referred to as "DRP/SRA") is a statutory authority established under Section 3-A of the Maharashtra Slum Areas (Improvement, Clearance and Redevelopment) Act, 1971 (Maharashtra Act No. XXVIII of 1971), and pursuant to Government Resolution No. SRA/2003/C.R. 189/SIUM-1A dated 04.02.2004 issued by the Housing Department, Government of Maharashtra, the Government has decided to implement the redevelopment of Dharavi as a comprehensive integrated development project;

And whereas, in discharge of its statutory duties, DRP/SRA has undertaken and successfully completed a comprehensive door-to-door survey within the Dharavi Redevelopment Project area pursuant to Public Notice No. SRA/DRP/Sub-Divisional Officer/F No. 318/277/2024 dated 11.03.2024, in accordance with

Government Resolution No. SRP 1000/C.R. 125/SRA-1 dated 16.05.2015 and Government Resolution No. SRP 0810/C.R. 96/SRA-1 dated 16.05.2018;

And whereas, upon scrutiny of the information and documents received during the survey, and in order to ensure adherence to the principles of natural justice, DRP/SRA deemed it appropriate and necessary to provide an additional opportunity to all concerned persons / household heads / slum dwellers / structure holders / owners, etc. (hereinafter referred to as “Household Heads”);

And whereas, DRP/SRA has, from time to time, issued several notices and reminders and provided reasonable and adequate opportunity to the concerned Household Heads to submit additional documents, information, and evidence;

And whereas, pursuant to Public Notice No. SRA/DRP/Sub-Divisional Officer-3/2024 dated 17.10.2025, Facilitation Camps were organized from 01.11.2025 to 15.11.2025, enabling Household Heads to personally attend and submit their documents and information;

And whereas, during the course of the survey, certain structures could not be surveyed due to non-participation, absence, closed premises, domestic disputes, or other reasons resulting in non-submission of documents. In respect of such cases, DRP/SRA conducted Information-Education-Communication (IEC) activities to create awareness and to appeal to the concerned Household Heads to submit the requisite documents and information;

And whereas, while many Household Heads responded positively to the IEC initiatives and submitted additional documents and information, despite repeated opportunities, certain Household Heads have still failed to submit the requisite information and documents;

And whereas, the competent authorities of DRP/SRA are carrying out scrutiny, examination, and verification of eligibility based on the information received from slum dwellers, and upon review of the draft annexures pertaining to the concerned area, it has been observed that despite repeated written and

oral communications, you have not submitted the information and documents required for the process of eligibility determination till date;

Therefore, in strict compliance with the principles of natural justice, procedural fairness, and transparency, this final notice is hereby issued by DRP/SRA, granting a last opportunity to all concerned Household Heads within the Dharavi Redevelopment Project area to submit the requisite information and documents relating to their respective structures.

NOTICE:

The required information and documents, along with a duly filled application, shall be submitted by courier, speed post, or in person at the address mentioned below. If the said information and documents are not received within 15 (fifteen) days from the date of publication of this notice, DRP/SRA shall take an appropriate decision based on available official records, survey data, and other valid sources, in accordance with applicable laws, rules, and Government Resolutions.

CLARIFICATION:

This notice is issued without prejudice to the statutory powers, authorities, and duties of DRP/SRA and the Government of Maharashtra, and nothing herein shall be construed as a waiver or relinquishment of any legal rights or remedies available to DRP/SRA.
